



## **ALKU Government Solutions Waiver and Pre-Employment Security Questionnaire**

I understand that the purpose of completing the Personnel Security Pre-Screen Questionnaire is relative to obtaining and/or verifying a personal security clearance, or access to national security information, and that my answers and statements on these forms are privileged information between the United States government, myself, my ALKU Government Solutions Resource Manager, Recruiter, and Facility Security Officer and will be limited to those with a documented need to know in accordance with the 1974 Privacy Act. Personally Identifiable Information (PII) may be submitted to an ALKU Government Solutions affiliated prime or government customer specifically for verification and validation of security clearance eligibility only.

By submitting this form, I hereby authorize ALKU Government Solutions to review any portion of the Pre-Employment Security Questionnaire necessary for the purpose of pre-screening a security clearance or the submittal of a security clearance request. I understand that the Pre-Employment Security Questionnaire will only be used for determining eligibility for, or verification of, a personal security clearance and access to national security information. Furthermore, I authorize ALKU Government Solutions and its Facility Security Officer to obtain and/or verify my security clearance and other relative personally identifiable information through various DoD and Intelligence Community systems of record.

I agree to hold ALKU Government Solutions, its agents, directors, employees, and/or affiliated primes and government customers, harmless and blameless for any claims, damages, losses, liabilities, costs, and expenses (including, but not limited to, attorney and/or legal fees), or any other charge or complaint filed, arising from the disclosing, retrieving, reporting, and use of the information referred to above during the process of obtaining and/or verifying a personal security clearance.

I certify that the information I entered on the Pre-Employment Security Questionnaire is true, complete, and accurate to the best of my knowledge and belief and is voluntarily made in good faith. I also certify that the answers provided on this form will be consistent



with information that will be provided on any additional forms required by ALKU Government Solutions to include, but not limited to, the Standard Form 86 (SF86). I also acknowledge that I have a right to decline to complete the Pre-Employment Security Questionnaire and if I decline, that such action will significantly impact my ability to be offered a position with ALKU Government Solutions. Moreover, I understand and agree that if I am hired and provided inconsistent, inaccurate, or incomplete information, such conduct may result in disciplinary action up to and including termination.
